

Wings of the City Raleigh Photo Contest

Terms and Conditions

The City of Raleigh (COR) and Dix Park Conservancy (DPC), along with the Jorge Marín Foundation, and the support of the Consulate of Mexico in Raleigh (CM), invite to the Wings of the City photo contest.

Through this contest, organizers promote Mexican sculptor Jorge Marín's Wings of the City exhibition in Raleigh, NC, and Dorothea Dix Park as a nature and culture destination for Raleigh and the region; It also seeks to generate a dialogue between the society that hosts the exhibition and the art of Jorge Marín, encourage the participation of different audiences, including the Purépecha community in Raleigh, as well as disseminate contemporary Mexican art and culture through this exhibition. .

1. Validity: February 1, 2022 to February 28, 2022

2. Territorial scope of the contest: Raleigh, North Carolina, United States

3. Participants:

Any natural person who meet the following requirements may participate:

- a) Being of legal age
- b) Has its own account on the social network Instagram

4. Mechanics

- a. Follow the Instagram accounts @dixpark, @dixconservancy and @jorgemarinmx
- b. Photograph one (1) of the nine (9) sculptures that are part of the Wings of the City exhibition at Dorothea Dix Park
- c. Post the image to your Instagram feed (not stories) using the hashtag #WingsOfRAL
- d. Tag @dixpark, @dixconservancy and @jorgemarinmx
- e. In the caption of the photo, include a word, phrase or quote that conveys what the sculpture or exhibition means to the participant

5. Requirements:

- a) Fully comply with these Bases
- b) The photograph must include one (1) of the Wings of the City sculptures from the exhibit at Dorothea Dix Park
- c) The participant may compete with a single photograph
- d) Different profiles of the same person may not be used to participate. Whoever does so will be immediately disqualified.
- e) The participant may not use a photograph that, directly or indirectly, violates the rights of the image, that belongs to third parties or violates any legal provision
- f) The participant must be the author and owner of the inherent, relative and derivative economic and related rights of the photograph with which he/she participates, as well as having the corresponding written authorizations to, where appropriate, use the image (including his/her voice). and name) of the people who are used in the image
- g) The participant guarantees and acknowledges being the owner of the intellectual property rights of the photograph, whether registered or unregistered, including graphics, videos, images, music, sound, texts, trademarks, trade names and other advertising information included therein.
- h) Participants may not use: the image (including name and voice) of minors, monuments, or archaeological sites when, in this case, authorizations are required for their use; or distinctive signs (brand, trade names, commercial notices, etc.) in the material with which they participate in the contest
- c) The photograph must not show offensive symbols that denigrate minorities or that have belonged to groups of religious, political-social repression
- d) In the photograph they must not appear nude, nor contravene the terms and conditions of Instagram

6. Selection of the finalist images

People will visit the dixparkconservancy.org/wingsofral website to vote for their favorite photo. Through this vote, ten finalist photographs will be chosen

7. Jury

Subsequently, a jury made up of members of the City of Raleigh, the Dix Park Conservancy, the Jorge Marín Foundation and the Consulate of Mexico in Raleigh, among the 10 most voted photographs, will choose the three winning photographs (1st, 2nd and 3rd place).

8. Results

The contest will be monitored by the City of Raleigh and the Dix Park Conservancy.

On March 4th, 2022, the organizers will announce the winners on their respective Instagram accounts @dixpark, @dixconservancy and @jorgemarinmx

9. Prizes

1st Place Prize: A lithograph by Jorge Marín

2nd place prize: Book Wings of the city, ten years

3rd place prize: Agenda Jorge Marín 2022

10. Contact with the winners

Once the winners have been determined, the City of Raleigh, the Dix Park Conservancy, and the Jorge Marín Foundation will simultaneously make the announcement on their Instagram accounts. An administrator of these accounts will contact the winners by private message and request the necessary data for the delivery of the prize.

Winners will have five business days from the date of the notification message to respond or acknowledge the announcement. If there is no response within that period, it will be understood as a waiver of the corresponding prize and, consequently, it will be transferred to the next participant in the list of possible winners.

The organizing committee will only make one contact attempt, so the information provided by the participant must be accurate and valid.

11. Award ceremony

Each winner will receive the prize that corresponds to him as described in these rules. There is no option to redeem the aforementioned prizes for cash or an item of equal or different value.

The prize will be delivered to the winners during the days following the closing of the contest and will be sent by mail or delivered in person.

Any violation of these bases, procedures and/or systems established for the realization of this contest, implies the immediate exclusion and/or revocation of the prizes to the winner.
